As you all know due to covid menace, the whole world was shattered; we too at Sandnya could not held our Annual General meeting last year. After the murderous 2nd wave, there was fear that the 3rd wave may again make the world upside down, but thank god that did not occurred.

Slowly the things started becoming normal here at Sandnya Sanwardhan Sanstha too. We started our activities slowly but steadily. After starting from alternate day schooling, regular schooling was started. All the rehabilitation units too started on regular basis. 'Gudhi' sale & 'Rakhi' sale was also very satisfactory.

The hostel project which was delayed because of corona has also been started & first slab of the two storied project of about 1500 Sq. ft building has been completed & we hope that by the end of Diwali the whole structure would be completed.

10 new admissions were made in this year & the total no. of students (both Schooling and Rehabilitations) is now 117.

A sensory park has been developed this year which would be quite beneficial to autistic children to develop their sensory organs. This sensory park was financed through CSR of KC International. We honestly thank them for the same.

Annual day was celebrated with fan and fare on 26th October at Mundle hall. The students performed and exhibited their talent in front of well wishers/donors and parents who were present in large numbers.

As usual our committed staff & volunteers contributed to the Sanstha in all respect. I thank them for their sincere contribution.

On behalf of all of us and on my personal behalf I thank our donors, local and abroad who help us to maintain our no government grant status for the last 29 years. I also take this opportunity to extend my heartfelt thanks to all schools and colleges for helping us arrange awareness meetings and also supporting us for selling our produce prepared by our special students and thus helping them in the process of their rehabilitation.

I thank all my trustees for their kind co-operation.

Secretary's Report for the Year 2022-23: I welcome you all to the 30th Annual General Body Meeting of Sandnya Sanwardhan Sanstha and it is my privilege to present before you the account of activities during the year 2022-23.

This year from 7th march we started schooling & slowly but steadily all the activities were started. All activities like Summer residential camp, Parent Relief Centre, Annual Programme were also started as usual of course sanitisation, wearing mask & social distancing were followed in total! Our school buses, class rooms were used to be cleaned every day, Temperature of the students was used to be checked by thermal scanner before the students enter into the buses which were also sanitised. By adopting these practises as a routine matter from 1st of June we started all our rehabilitation units & from 15th of June daily schooling was also started.

This year 10 new admissions were made, out of which 8 were in schooling group and two each in vocational & rehabilitation units.

Special Education: Curriculum of all 10 classes of special education was started on regular basis. It



was based on the guidelines of Project Disha. Accordingly parents were also made the part of it by making them aware of school and homework activities. I am happy to inform you all that the Social work department of State Government honoured us with the certificate of excellence for the same.

In covid time, school was closed due to lockdown but inspite of this the students responded very enthusiastically, when the school was reopened.

In March this year two special educators left the job. One was made to resign for his indisciplined behaviour and the other

resigned on his own. The posts so vacant would be filled in the comming session.

Developmental Therapy: 45% of our students suffer from multiple disabilities & many of our students lack general fitness and require therapy to minimise body weight. This year 70 students

were given physiotherapy, out of this for 25 students, therapy was given to minimise their body weight. Physiotherapy was given was for 30 minutes in average to each student. To some students, physiotherapy was given daily & to some, every alternate day.

As the school was closed, physiotherapy could not be given to many students but once the school is started many students like, Ashwini, Siddhi, Najiya, Alina, Saket, Prajwal, Piyush etc. were benefitted immensely.

Today we have one regular physiotherapist in our school. She provides physiotherapy to 45 students with 3 assistants to help

her every day. We are also in need of a occupational therapist for our students & hope that we will get one in near future.

Rehabilitation Unit: Along with school all rehabilitation units such as Gudhi Unit, Handloom Unit, Rakhi Unit, File Making-Screen Printing Unit, Bouquet Unit have also started working. From April 18th StarCirclip unit started working too.

सचिव अहवाल वर्ष 2022-23:

संज्ञा संवंधन संस्था की इस 30 वीं आम सभा मे आप सभी विश्वस्तो का हृदय से स्वागत है। वर्ष 2022-23 की गतिविधियों का आलेख आपके सम्मुख प्रस्तुत करते हुए मुझे महत् प्रसन्नता हो रही हैं।

जैसा हमने पिछले वर्ष के अहवाल में बताया था, 7 मार्च से विद्यार्थियों को अल्टरनेट दिन में स्कूल में बुलाना शुरु हुआ। इसके बाद के महिनों में धीरे धीरे सभी गतिविधियों को हमने पूर्ववत शुरु करना प्रारम्भ कर दिया।

निवासी शिविर, पालक राहत केन्द्र, वार्षिकोत्सव कार्यक्रम जैसी गतिविधियाँ पहले के जैसे ही ली गयी. शुरुवात के दिनों में SMS यानि सॅनिटायझेशन, मास्क और सोशल डिस्टर्निसंग का पूरी तरह पालन किया गया. स्कूल बस, क्लासेस को बार बार साफ़ करना, बसमे बैठने से पहले बच्चों का तापमान चेक करना, इनको हमने अपने रोज की दिनचर्या में शामिल कर लिया था। 1 जून से रिंहैबिलिटेशन यूनिट्स तथा 15 जून से स्कूलिंग के बच्चों को डेली स्कूल बुलाना शुरु किया गया।

इस वर्ष 10 नये प्रवेश दिये गये जिसमे से 8 स्कूलिंग ग्रुप में और 2 व्होकेशनल और रिहैबिलिटेशन यूनिट में दिये गये। इस साल पहली बार ऐसा हुआ की जिन बच्चों का एडिमशन हुआ उनमें से 3 बच्चों ने कुछ दिनों के बाद स्कूल आना बंद कर दिया। साल के आखिर तक 2 और बच्चों ने स्कूल छोड़ दिया। इसका कारण हम किसी को भी नही बता सकते क्योंकि कई बार ऐसी परिस्थितीयाँ बन जाती हैं जिसमें से निकलना मुश्किल हो जाता है।

विशेष शिक्षण:

विशेष शिक्षा के सभी 10 क्लास में बच्चों का अभ्यासक्रम अपने नियमित समय से शुरु हुआ। जैसा हमने बताया था ''प्रोजेक्ट दिशा'' के अनुरुप बच्चों के अभ्यासक्रम इस प्रकार तैयार किये गए जिससे स्कूल में सिखाये जाने वाले एक्टिविटिज के साथ साथ घर में सिखाने के लिए घरेलू लक्ष्य (Home Goal) भी पालकों को बताये गये। कोविड के समय में जो स्कूल में आकर सीखने का गैप हुआ, उसके बावजूद बच्चों में प्रतिसाद (response) अच्छा रहा। जैसा हमने पहले ही बताया, नए एडिमशन वाले बच्चों में से कुछ ने स्कूल आना पसंद नहीं किया। साल के आखिर तक 2 बच्चों को पालको ने



भेजना बंद कर दिया। कई बार ऐसा हो जाता है कि पालक हमसे जो अपेक्षा रखते है वो पूरा नहीं हो पाता और उसका परिणाम इस प्रकार का होंता है। मार्च महीने में 2 स्पेशल एज्युकेटर ने नौकरी छोड़ी है और अगले सत्र में हम नए स्टाफ को नियुक्त करेंगे।

विकासोन्मुख उपचार (Developmental Therapy) :

हमारे 45 प्रतिशत से अधिक विद्यार्थीं यों में बहुविकलांगता है और कई बच्चों को सामान्य फिटनेस और वजन कम करने के लिए भी थेरपी की जरुरत है। इस साल 70 बच्चों को फिजिओथेरपी की सुविधा दी गयी जिसमें से 25 बच्चों को फिटनेस के लिए और वजन कम करने के लिए थेरेपी दी गयी। बच्चों को एवरेज 30 मिनट थेरेपी दी गयी और कुछ बच्चों को हर दिन तथा कुछ को एक दिन छोड़कर थेरेपी दी गयी। हमें बताते हुए खुशी होती है कि स्कूल और थेरपी बंद होने के कारण बच्चों में जो समस्या आई थी उसको हम काफी हद तक नियंत्रीत कर पाए है। कु. अश्विनी, कु. सिध्दी, कु. नाजीया, कु. अलीना, साकेत, प्रज्वल, पियूष ऐसे कई बच्चों से हमें सकारात्मक प्रतिसाद मिला है। एक फिजिओथेरपीस्टि और तिन सहायकों द्वारा बच्चों को थेरेपी की सुविधा दी जाती है, हमें अभी भी एक ऑक्यूपेशनल थेरेपिस्ट की जरुरत है।

This year the procedure to bundle the clips was changed. In this new system common headed clips were to be bundled on one side which requires more time but our students responded positively to this new system also. All the students working in Rehabilitation Units are now getting regular honorarium.

Medical Check-up: Three medical check-up camps were organised for students after the re-opening of the school. (Two were by Dr. Ravi Deshpande for general check-up & one by Dr. Akash Saoji for Ortho problems.)

Parents Meeting: In all eight parents meeting were conducted. Four meetings at Butibori for the parents residing nearby Butibori & four meetings for parents residing at Nagpur. Nagpur meeting were conducted at Pratap Nagar Primary School hall. These parents meetings were conducted to make the parents aware of

the progress of their wards and also to make them aware of the future plans of the Sanstha.

Cultural Activities: 15th August: Independence day was celebrated with full galore. It was the first occasion after covid to which students, parents, staff & trustees of the Sanstha, all were present in good number.

20th August - Dahihandi was celebrated in the presence of students, trustees, staff & parents.

5th September - 'Teachers day' was celebrated by felicitating the teachers & staff members by giving them gifts as a token of appreciation.

From 31st August - Ganesh Festival was celebrated with full enthusiasm for 10 days.

On 16th October 'Annual Day' of Sanstha was celebrated at 'Mundle Hall'. This year the theme of



Annual Day was "दुख से सुख की ओर" (From Sorrow to Happiness). The Chief Guest on this occasion was Air Marshal Shri. S. B. Deo (Chairman JSR Dynamics). The function was presided over by Swami Gyangamyanand of Ramkrishna Math, Nagpur.

On this occasion parents, donors & well wishers of the Sanstha were present in large number. The hall having seating capacity of around 1000 nos. was almost packed.

Our students showed their art & skill by presenting beautiful acts of play and dances. In all 83 students participated in the programme.

The 3rd of December was celebrated as 'World Disabilities Day' at our school at Butibori. Students did tree plantation and gave performances in singing, instrumental music and drawing pictures etc.

On 10th December, students went on picnic to "Mosaic Adventure – Mohagaon Zilpi". Our student were given 'free entry' at Mosaic Adventure as a gesture by Mr. Ravindra Gande, the owner. The 26th January – Being 75th Republic day it was celebrated with great enthusiasm in our school at Butibori. The whole premises was colourfully decorated to mark 'Amrut Mohotsav' of independence.

Parent Relief Centre (PRC): Four parents took advantage for 6 times of PRC facility. On total PRC was used for 31 days. This facility can be utilised by parents twice in a year for 7 days each time.



पुनर्वसन केन्द्र (Rehab Units) :

स्कूल के साथ ही हमारे रिहॅबिलीटेशन युनिट भी शुरू हो गए। गुढी युनिट, हातमाग युनिट, राखी युनिट, स्क्रीन प्रिटींग युनिट और फाईल युनिट युरू हो गए। 18 अप्रेल से स्टार सरक्लिप यूनिट शुरू हो गए। 18 अप्रेल से स्टार सरक्लिप यूनिट शुरू हो गया। इस बार क्लिप के बंडलिंग का तरीका बदला हुआ था, जिसमें छात्रों को समान हेड वाले क्लिप्स को एक तरफ करके बंडल तैयार करना पड़ता है। जाहिर है कि इसको करने में समय अपेक्षाकृत अधिक लगने वाला है। सभी यूनिट में काम करने वाले बच्चों को मानधन मिलना शुरू हो गया है।

चिकित्सा जांच (Medical Checkup) :

स्कूल शुरु होने के बाद ग्रामीण रुग्णालय के द्वारा स्कूलिंग ग्रुप के बच्चों का मेडिकल चेकअप किया गया। इसके अतिरिक्त 3 मेडिकल चेकअप सभी बच्चों के किये गए (दो डॉ. रवि देशपांडे सर और एक डॉ. आकाश सावजी सर द्वारा)

पालक सभा :

इस वर्ष आठ बार पालक सभाए ली गयी। बुटीबोरी और आसपास के पालकों के लिए स्कूल में पालक सभा रखी गयी और नागपुर के पालकों की पालक सभा प्रताप नगर प्राथमिक विद्यालय के हॉल में



ली गयी। इन सभाओं का उद्देश्य बच्चों के लिए स्कूल में क्या सिखाया जाता है इसको बताने के साथ ही पालकों के शंकाओं का निराकरण करना भी होता है। इसके अलावा संस्था की भावी योजनाओं के बारे में पालकों को जानकारी दी जाती है।

कल्चरल ॲक्टिविटी:

1 5 अगस्त को ध्वजारोहण हर्षोल्लास के साथ मनाया गया। कोविड के बाद यह पहला कार्यक्रम था जिसमे विद्यार्थी, पालक गण, स्टाफ तथा संस्था के पदाधिकारी उपस्थित थे। दिनांक 20 अगस्त को दही हंडी का कार्यक्रम पालक, विद्यार्थी, स्टाफ तथा ट्रस्टीज की उपस्थिती में मनाया गया। 5 सितम्बर को शिक्षक दिन के अवसर पर सभी ट्रस्टीज् ने मिलकर सभी स्टाफ का सत्कार किया और उनको भेटवस्तु दी। 31 अगस्त से 10 दिवसीय गणेश उत्सव मनाया गया।

16 अक्तुबर को मुंडले हॉल में संस्था का वार्षिकोत्सव मनाया गया जिसका थीम था ''आनंद दुख से सुख की ओर''। कार्यक्रम के मुख्य अतिथी के रूप में एयर मार्शल एस. बी. देव (वेयरमन – जे एस आर डायनामिक) और स्वामी ज्ञानगम्यानंद जी (रामकृष्ण मठ, नागपूर) उपस्थित थे। इस कार्यक्रम में 83 विद्यार्थियों ने सहभाग किया था।

3 दिसम्बर को जागतिक दिव्यांग दिन का आयोजन बुटीबोरी स्कूल में किया गया। इस बार से हमने इस दिन को मनाने का निश्चय किया है। इस कार्यक्रम में बच्चों ने वृक्षारोपण, चित्रकला, गीत गायन, म्यूजिकल वाद्य बजाना जैसी एक्टिविटीज स्वतंत्र रूप से की। 10 दिसंबर को बच्चों की पिकनिक "मोजैक एडवेंचर", मोहगांव (झील्पी) गयी थी। वहाँ के प्रबंधन द्वारा बच्चों को निःशुल्क प्रवेश दिया गया। 26 जनवरी (अमृत महोत्सव) का कार्यक्रम भी पुरे जोश के साथ स्कूल में मनाया गया।

पालक राहत केन्द्र (PRC): पूरे साल में 4 पालकों ने कुल 6 बार राहत केंद्र का लाभ लिया। इस प्रकार 31 दिन यह राहत केन्द्र सिक्रिय था। यह सुविधा पालक साल में दो बार ले सकते है और एक बार में 7 दिन के लिए ही ये सुविधा दी जाती है। Parents' Workshop/Staff Workshop: On 20th November a one day workshop was conducted at Butibori school premises. Dr. Mausam Firke (Psychiatrist) was the guest faculty and guided the parents on counselling of special

parents.

On 10th March 2023 a workshop was arranged for parents at Butibori. Dr. D. S. Bhamre and Dr. Mrs. Leena Bhamre conducted the workshop and guided the parents on "Counselling and Meditation". The 75 parents from Butibori and Nagpur took part and thoroughly enjoyed the workshop.

On 11th March the same workshop was arranged for the benefit of our staff and was well received. On both day lunch was provided by Sandnya Sanwardhan Sanstha to parents and staff.



Public Awareness: 5 public awareness meetings were conducted. Four at Butibori and One at Nagpur.

Residential Camp: From 4th May to 10th may, a residential Camp was conducted at Butibori. Secretary of Sandnya Sanwardhan Sanstha, himself participated in the camp. 15 students and 5 girls participated in the camp.

Our principal and staff too attended the camp and ladies staff was specially deputed to look after the girls who participated in the camp. During camp days students did the activities like drawing and painting, craft work, yoga, shramdaan, singing bhajan etc. Students whole heartedly enjoyed the camp. The response of all the students was wonderful.



At the end of the camp students were taken for a 'Joy Ride' at Nagpur Metro. The Metro management made special arrangement for this ride. This initiative by Nagpur Mahametro was very much appreciated by one and all. The management of Sandnya will be always grateful to Nagpur Metro for this gesture.

Promotions: Two staff were promoted in the new calendar year i.e. from January 2023. Mr. Alok Dwivedi, who was working as the Principal, has been promoted as Director of Kalpataru Special School and senior Special Teacher, Mrs. Medha Kulkarni madam has been promoted as Principal. On behalf of the organisation, the President and Secretary declared this to all the staff in the staff meeting and both the staff were given bouquets and best wishes.

Achievements: Some remarkable achievements were made by the organisation this year. First, on August 13, the institution was honoured by the Nagpur District (Rural) Police for its incomparable work. Second our Director Shri. Alok Dwivedi was honoured for his remarkable work on Teacher's Day, this programme was organised by the Regional Deputy Commissioner of Social Justice and Special Assistance Department, Social Welfare Department, Nagpur. Third Kalpataru Special School has been awarded the Certificate of "Disha Implementing School" by The Commissioner, Disabled Welfare, Maharashtra State, Pune for completing all the phases of "Disha Curriculum" effectively and on time.

Admission Procedure

- 1) New admissions for every session will start from 2nd May.
- 2) The vacancies in each class will depend on the promotion of students from lower class to upper class.
- 3) Those wishing to take admission will have to submit an application in the printed format, during the month of April. Such printed application format will be available either at our Nagpur office or Butibori school.
- 4) This application duly filled in and attached with one recent passport size photo and disability certificate from appropriate authority in respect of the concerned student can be submitted either at our Nagpur office or Butibori school. No application will be accepted before 1st April. Application will not be accepted without UDID certificate.
- 5) The admissions will be given to students strictly on first come first serve basis. We maintain 100% transparency in this procedure.
- 6) After scrutiny of the application the parents along with the student will be called to Butibori campus for the concerned student's assessment.
- 7) Depending on the assessment and availability of seat in that particular class, admission will be given.
- 8) Such admission if made will be on probation basis for three months, during which the acceptability of the student will be under scrutiny.
- 9) After three months if everything goes on well the admission of the student will be made regular.
- 10) While making such regular admission the location of the parents and their suitability to access our school bus route will also be considered.
